Famed Sebastian Naturalist George Nelson's Glass Slides Come to Life at our June 30th Meeting

Florida State Genealogical Society President Pamela Cooper has very kindly agreed to do a power point presentation of the George Nelson glass slide collection dating back to the early 1900's. Nelson first came to Sebastian from Maine in 1901 and took thousands of photos of the flora and fauna of Indian River County; 2500 of his glass and hand-tinted lantern slides are still safely stored in archival boxes. In September 1963, the collection was donated to his cousin Helen Stewart's private library following his death in 1962. Nelson ended a long career working for Harvard University as a collector, preparator, botanist, zoologist, ornithologist, and passionate photographer. Most of his manuscript



collections are at Harvard. However, his glass slide collection is by far the largest visual collection of his work and is now located in the Archive Center of the Indian River County Main Library. All items have been preserved, scanned, and made available for viewing at the library. An article about George Nelson recently appeared in the May 15th issue of <u>Vero Beach 32963</u>.

Cooper, supervisor of the Archive Center, will give a biographical sketch of George Nelson and show slides of Pelican Island, Swan Island, Honduras, Cuba, and a small portion of his many slides of flowers and wildlife. This presentation promises to be a one-of-a-kind opportunity to learn about one of the area's greatest naturalists. The meeting is free and open to the public. Please join us at 7:00 p.m. at the North Indian River County Library, 1001 Sebastian Blvd. in Sebastian on Monday, June 30th. Light refreshments will be served.

Butterflies, and Bees, and Birds!--Oh, My!

Did you know that over 150 food crops in the U.S. depend on pollinators, including oranges, tomatoes, and almonds? Kevin Lowry, Visitor Services Manager at the PINWR, is inviting all who are interested to a FREE family program on pollinators on Saturday, June 21st at 10 a.m. to learn about the butterflies of Florida and how they may become regular visitors to your backyards. Fertilizer Ban Now in Effect (June 1st-September 30th)

Indian River County has adopted a new fertilizer ordinance restricting fertilizer application in order to help protect the ailing Indian River Lagoon from excess nutrients contained in summertime runoff. These nutrients contribute to the growth of algae blooms, which then cut off the oxygen supply to grow sea grass, a major food source for manatees as well as habitat for new-born fish.

No fertilizer containing phosphorous is to be used at any time, and all fertilizers must contain at least 50% slow-release nitrogen. No fertilizer is to be applied within ten feet of any body of water. Now that the rainy season has arrived, we certainly don't want to endure another crisis similar to last summer's when we lost over 300 manatees, 70 dolphins, and countless birds and fish. Let's all do our part to help our beloved Lagoon regain its health.

Archie Carr National Wildlife Refuge and Summer Turtle Walks

Directly across the street from the Pelican Island NWR lies another refuge comprised of 20.5 miles of protected habitat, extending from Wabasso to Melbourne Beach--Archie Carr NWR. Its significance lies in the fact that it is the world's #1 most productive nesting site for Loggerhead sea turtles. Leatherback and Green sea turtles also choose these beaches as nesting sites. The Refuge was named in honor of Dr. Archie F. Carr, a conservationist who, through his writings and research, brought attention to the plight of sea turtles and their possible extinction if protective actions were not taken to help them survive.

Those of us living in Indian River County are fortunate to be surrounded by caring and educated environmentalists who see that turtle nesting season (March 1st-October 31st) and its associated ordinances are strictly adhered to. You can learn more at www.TurtleNests.org.

Kristen Kneifl, Archie Carr NWR Refuge Ranger, has set aside July 12th as the primary date on which members of PIPS and their families may attend a nesting presentation and turtle walk at the Barrier Island Center on A1A in Melbourne Beach. July 5th has been set aside for Turtle Coast Sierra Club members, but PIPS members may attend on that date if they cannot make the 12th. These walks are offered without charge, but donations to the Friends of the Carr Refuge are greatly appreciated.

Instructions for night time turtle walks are included on each website. We encourage all PIPS members to take advantage of this unique summertime wildlife experience.

Certified ranger-led tours are also available to the public at Sebastian Inlet State Park during June and July. Turtle walks are held nightly, Friday through Tuesday, and reservations are required.
